Brenda's Situation

Brenda, 77, is independent and mobile, with family and friends nearby. Until recently, she also had her son in London who, though not present day to day, supported her emotionally and was a sounding board for life's admin. They were incredibly close.

When Brenda lost her husband in 2021, a long journey of legal paperwork, property matters, and complex decisions. I started supporting her during that time, helping with the many practical tasks that fall outside legal advice but still feel overwhelming.

After her son's unexpected death last year, the load increased: sorting documents, handling UK and overseas property, understanding legal correspondence, and keeping on top of everyday admin, all while grieving.

- Booking engineers, returning equipment, and managing systems and emails

• Being a calm presence at property related meetings

- Accompanying her to UK appointments
- Offering to travel overseas if needed (an offer she valued, though ultimately not required)
